Weekly Review

- Patrol responded to at least three (3) Mental Health Crisis calls.
- A Traffic Stop resulted in the arrest of a 35-year old male for driving Cancelled-Inimical to Public Safety.
- Patrol responded to an Assault in Progress call between two neighbors. One of them was allegedly speeding through the neighborhood, upsetting the other. Both women provided conflicting stories over who was the aggressor. Both were cited for Disorderly Conduct.
- Patrol arrested a 21-year old male, at Kenrick Loop and Kenrick Avenue, after finding him passed out behind the wheel of his idling vehicle. He tested a .18 BAC and was charged with 2nd Degree DWI.
- Fraud Activity reported after the victim's email was hacked. The unknown suspect emailed asking for ten iTunes gift cards and wanted pictures of them. The pictures were sent before the fraud was realized.
- Attempted Burglary occurred at 17XXX Kenwood Trail after unknown suspect(s) tried to enter the store by way of a block thrown through the front window. The attempt set off the alarm and the suspect(s) fled.
- Patrol responded to a Traffic Accident at Cedar Avenue and Lakeville Boulevard. A motorcycle crashed after performing a quick maneuver as a car stopped in front of him. He sustained, what appeared to be, a broken collarbone and was transported to the hospital.
- Theft from Vehicle reported at 19XXX Ritter Trail. A window was broken out and a purse was stolen.
- More pizza this week – and it must have been good! Patrol found a 23-year old male, parked between stalls, passed out in his vehicle at 16XXX Cedar Avenue. He had a slice of pizza in his hand. Once Officers were able to wake him, he finished his slice of pizza and performed SFST's. Unfortunately, he failed them and he has formal charges pending.
- Theft from Vehicle was reported at 16XXX Jatos Circle. The rear window was smashed out overnight.
- Theft was reported from 1XX Anthony Drive after the mailbox was force open and mail was stolen.
- A Traffic Stop, at Dodd Boulevard and Elm Creek Lane, for a Speeding violation resulted in Underage Consumption violations for two 19-year old males.
- Responding to a Drunkenness call, Patrol arrested a 31-year old male for 2nd Degree DWI Test Refusal.
- Officers responded to a Traffic Accident at 185th Street West and I-35. A motorcycle failed to stop at the light and collided with a vehicle with a green light. Medics transferred the driver of the motorcycle to the hospital for care.
- A 24-year old female was arrested for violating a Harassment Restraining Order.
- Fraud reported by a victim who received a \$150,000 bill for a loan she didn't take out.
