Weekly Review

- Vandalism and Burglary was reported at 16XXX Highview Avenue after unknown suspect(s) kicked in the garage door and stole a weed trimmer.
- A Traffic Stop, at 205th Street West and Lucerne Trail, resulted in the 3rd Degree DWI arrest of a 51-year old female.
- Patrol responded to at least six (6) Mental Health Crisis calls.
- Theft was reported at 21XXX Cedar Avenue. A trailer was broken into and multiple items were stolen.
- Theft from Vehicle was reported at 18XXX Dodd Boulevard. The victim's car window was smashed out and a purse was stolen.
- Fraud Activity reported from 9XXX 185th Street West after a check was stolen from the mailbox, rewritten for a higher value and cashed.
- Officers responded to a Driving Complaint. A 50-year old female was subsequently arrested for DWI after failing SFST's.
- Officers were called to 11XXX 210th Street West on a report of a drug deal. Officers located a 28-year old male with a large amount of narcotics, including mushrooms, heroin, and meth. He had two Felony Warrants for, you guessed it, Controlled Substance. He was jailed.
- Traffic Stop, at Kenwood Trail and Jubilee Way, found the 47-year old male driver impaired. He also had an active Warrant for 2nd Degree CSC. He tested a .11 BAC and was jailed on fresh charges of 2nd Degree DWI, GM False Info and traffic related charges.
- Mail theft reported from 11XXX Knolls Path.
- Patrol arrested a 29-year old female for 4th Degree DWI after she was pulled over for Speeding. She was found to be impaired, failed SFST's and provided a .10 BAC.
- A 34-year old male stole a trail camera from Fleet Farm and was cited for Theft.
- After mediating a Domestic Disturbance, between an impaired husband and wife, the 44-year old male decided to go outside and antagonize some neighbors, trying to start a fight and hurling profanities. When one of the neighbors started to film him, he pulled his pants down, exposing himself. Needless to say, he was arrested for Disorderly Conduct and Indecent Exposure.
